Kinmount & District Health Centre (KDHC) is located on  
County Road 503 in Kinmount, in  
Trent Lakes Municipality, County of Peterborough and  
serves the areas of Kinmount and the surrounding communities.



KDHC is staffed by one family physician,  
Dr. Elena Mihi  
Physiotherapist, Sandra Butler,  
and two Medical Receptionists, Nellie Gluck, and Lisa Russell  
who also provide Laboratory Services for patients only.



Kinmount Pharmacy operates a full service pharmacy  
under the ownership of Samuel Iskander.
